How we use Collected Information

Use of our services

Communication

If you send an e-mail or other messages to us, we may save those messages. Sometimes we will ask for your personal information if that is relevant to the situation in question. This allows us to process your requests and answer your questions. The data is stored on Intercel's own secure servers or those of a third party.

Cookies

We collect data for analysis in order to gain better insight into our customers, so that we are able to tailor our services accordingly.

This website uses 'cookies' (small text files stored on your computer) to help the website analyse how its being used. The information generated by the cookie about your use of the website can be transferred to Intercel's own secure servers or those of a third party. We use this information to keep track of how you use the website, to compile reports on website activity and to offer other services related to website activity and internet usage.

Purpose

We do not collect or use information for any other purposes than those described in this privacy policy unless we have obtained your consent in advance.

Third parties

Collected information will not be shared with third parties. In some cases the information can be shared internally. Our employees are obliged to respect the confidentiality of your information.

Alterations

This privacy statement is tailored to the use of and the possibilities on this website. Any adjustments and / or changes to this site may lead to changes in this privacy statement. It is therefore advised to regularly consult this privacy statement.
